- **Central Securities Depositories (CSDs)** are systemically important institutions in capital markets. They hold electronic records of financial instruments like equities and bonds, and play a crucial role in facilitating secure and efficient settlement of transactions in these assets. CSDs ensure transparency, reduce counterparty risks, and promote the overall stability and integrity of financial markets.
- **Eurasian, African and Middle Eastern CSDs** play a significant role in the dynamic and rapidly evolving capital markets of their region. With the markets experiencing impressive growth, these CSDs have emerged as global leaders in providing innovative services. Their contributions extend beyond borders, facilitating seamless cross-border transactions, promoting investment, and fostering international collaboration, making them essential players in the global financial landscape.
- As the Central Securities Depository and Trade Repository of the Turkish capital markets, **Merkezi Kayıt Kuruluşu A.Ş. (MKK)** provides its members with depository, data and trade repository, corporate governance and investor services. MKK also offers in-house developed data and technology systems and platforms to local and foreign capital and financial markets as part of its role as an R&D center.

- The foundation for the subsequent formation of the Association of Eurasian Central Securities Depositories (AECSD) was initiated in 2001 by the Central Securities Depositories of the Commonwealth of Independent States (CIS) countries. The formal establishment of AECSD occurred in Moscow in 2004 by the signing of the Resolution outlining the creation of the Association.
- The aim of the Association is to develop and expand inter-institutional securities depository operations, create a common space for central securities depositories and integrate them into global depository systems.
- MKK is a member of AECSD since 2015. Currently, MKK CEO and Board Member Dr. Ekrem ARIKAN is the term Chairman of the Association, and the AECSD & AMEDA Summit will be held in Istanbul in 2024 with the coordination of MKK.
- AMEDA was founded on April 27, 2005, and held its inaugural meeting in New York before the CSD 8th conference. This non-profit organization is made up of Central Securities Depositories and Clearing Houses in Africa and the Middle East.
- The primary objective of AMEDA is to provide a platform for its members to exchange information and experiences, while also supporting the development of local markets through mutual cooperation. Additionally, AMEDA aims to promote best practices in services such as depository, clearing, settlement, efficiency, risk management, corporate governance, and other related areas on a global scale.
