# BISTECH Trading System

- Borsa İstanbul has ownership of operating licenses and source codes of the BISTECH technology as well as ownership of the re-sale rights in 27 countries including Türkiye.
- Services provided in the region covering Turkic countries, Balkans, the Middle East and the Far East
- + 250 IT personnel including analysts, developers, testers and system integrators

Türkiye Mercantile Exchange (TÜRİB/TMEX) was established in 2018.

In less than 6 months, BIST completed the adaptation and onboarding of BISTECH Technology to TÜRİB with parametric market configuration. The experience and expertise of BIST in this area made it possible to flow this transition smoothly.

TÜRİB Spot Market (Electronic Product Agreements - Elüs) started to trade with BISTECH technology in 2019.

# KASA

Standard and/or Nonstandard precious metals that have features below can be traded in the KASA is a platform that works integrated with GENIUM trading and clearing system, manages the inventory of precious metals, provides physical clearing and settlement of precious metal transactions in and out of the market and manages custody operations on member and customer basis.

The platform, which works on micro services with a web-based interface and has a high level of redundancy and service continuity, is compatible with GENIUM product groups as well as can be integrated with different technologies.
